LEGISLATIVE PRIORITIES

REINVESTING IN STUDENTS

State University Faculty Support:

- \$350 million to fund the MinnState request.
- \$137 million increase in base campus funding to close campus structural deficits created by legislative disinvestment and unfunded tuition restrictions going back to 2015.
- \$8 Million to fully fund the NextGen Project and reduce the burden on campus budgets.
- Increase the employer contribution for the Individual Retirement Account Plan (IRAP) that matches the TRA employer contribution.
- \$750,000 to expand state funding of the Inclusive Higher Education Grant program to design postsecondary programs for students with intellectual disabilities.
- Fully fund and reestablish the authority of the Public Employment Relations Board (PERB).
- Funding for 4 years of tuition-free attendance at a Minnesota state college and/or university
- Increase funding to cover the full costs associated with students enrolled in Concurrent Enrollment or PSEO.
- \$3 million in operational funding for Minnesota's Tribal Colleges.
- Increased funding for the Teachers of Color Act (ITCA).
- Investments to enhance and promote campus safety.
- Invest in campus infrastructure by fully funding the MinnState Capital Investment request.

EQUITY AND CAMPUS SAFETY

State University Faculty Support:

- Legislative policies which respect the inherent worth and dignity of all students, faculty, and staff and that foster an actively engaged learning community based on justice, equity, and inclusiveness.
- Protections for bodily autonomy, including gender-affirming health care, access to abortion, and other reproductive health care.
- Allowing campuses to restrict visitors from carrying firearms through the reasonable request process.
- Support indigenous students by strengthening partnerships between Minnesota State and Minnesota Tribal Colleges.

VOTING RIGHTS

State University Faculty Support:

• Increasing access to voting, including expanding mail voting, automatic voter registration, early voting, and restoring the right to vote for those living in the community.



LEGISLATIVE PRIORITIES

STATE GRANT REFORMS

State University Faculty Support:

- Reforms to the State Grant Program that increase Living and Miscellaneous Expenses (LME).
- Change State Grant and Scholarship guidelines to expand opportunities for all Minnesotans.
- Restrict or eliminate State Grant awards to for-profit higher education entities.
- Strengthen institutional eligibility requirements for the State Grant Program.

PROTECTING ACADEMIC FREEDOM

State University Faculty Support:

- Limiting the authority of the MinnState system office and stopping administrative growth.
- Empowering faculty to truthfully educate students so they may critically identify and analyze all forms of discrimination.
- Faculty maintain control of all curricular and academic decisions, including transfer. Faculty oppose partnerships with Online Program Management (OPM) companies.

LABOR RIGHTS

State University Faculty Support:

- Protect and strengthen collective bargaining rights.
- Change PELRA's definition of "year" to include courses taught outside the fall and spring semesters to expand IFO representation.
- SEGIP requirement to cover costs for dental work that is necessary due to a medical procedure or condition.
- The expansion of accessible and affordable healthcare for all Minnesotans.
- Ending any requirement of health coverage for an ex-spouse of a state employee.

TAXES

State University Faculty Support:

- Permanent state revenue increases that target those with the ability to pay their fair share and that make the tax system more fair, equitable, and just.
- Exempting President Biden's one-time student loan forgiveness from state and federal taxes through Federal tax conformity.
