

What is Advantage Value?

For SEGIP Minnesota Advantage Health Plan members diagnosed with diabetes, this benefit reduces member out-of-pocket costs (copays and coinsurance) for high-value medical services that are primarily for diabetes, as well as for certain prescription drugs and testing supplies. High-value services reduce the progression of diabetes and the risk of costly complications.

Who is eligible?

Adult (18+) SEGIP members (whether active participant, dependent, retiree, or former employee who has continued coverage) are eligible if they have been diagnosed with Type I or Type II diabetes. Advantage Consumer Directed Health Plan (High-Deductible) members are not eligible. Please visit SEGIP's website at mn.gov/mmb/segip for more details on eligibility.

Your health is important.

Diabetes is a chronic disease, relatively common among adults, that can be effectively managed with the right care at the right time.

Consult with your doctor regarding the appropriate care for you.

How do eligible members get the new benefit?

Starting in 2018, if you receive an eligible medical service or drug for diabetes, you will begin receiving discounts on certain medical and pharmacy costs. Members do not need to enroll, benefits will be applied through your health plan or CVS Caremark, SEGIP's new pharmacy benefit manager in 2018. See the back of this handout for how much eligible members can expect to pay in 2018 for care that is primarily related to diabetes. Cost sharing for diabetes care will be minimal in Cost Levels 1 & 2 (and for Tier 1 drugs) and modest for Cost Levels 3 & 4 (and for Tier 2 & 3 drugs). To minimize your costs, choose a health plan during Open Enrollment that offers your primary care clinic at the lowest cost level.
